Investment Objective

The investment objective of the Fund is to provide a long-term total return above that of the UK consumer price index. The Fund will be actively managed and invest in multiple asset classes with a portfolio of transferable securities which may include investment trusts, collective investment schemes, deposits, money market instruments, derivatives and other alternative investments such as structured products, commodity and property funds. The investment manager has the discretion to weight the portfolio towards any investment type, or geographical region, at any time provided it is compatible with the investment objective, risk parameters and policy of the Fund as a whole.







Portfolio activity and comment

Global markets staged a rally from the December lows, driven in most part by the USA. An easing of tensions between the USA and China was especially welcome and overshadowed a fall in manufacturing data which, being the worst since 2008, would normally have rattled equities. Markets were even prepared to look through the ongoing government shutdown and, in fact, jobs data was reasonably good with wages rising 3.3% year on year. US corporate earnings season started well. Combined with the Federal Reserve comments that they were prepared to be more patient with regard to further interest rate rises in the face of an easing of inflation, the elements were in place for a rally which saw the S&P500 rise 8% for the month. In the UK, wages also rose by 3.3% annually with the unemployment rate falling to just 4%. However, Brexit dominated the headlines with Prime Minister Theresa May's EU deal being rejected with no further vote until mid-February simply creating more uncertainty. The FTSE 100 rose 3.5% European political stresses eased with the EU making concessions to Italy thereby removing short term fears. The fund rose 0.87% in January.

Christian Holland - Christian has over 30 years in the City. He managed Japanese equities for 16 years, initially with Provident Mutual. He has also managed multi-asset portfolios with UBS Wealth Management, Cavendish and TAM Asset Management where he also developed ethical portfolios. Christian has been regularly featured in the media with appearances on TV and radio.
